THE CLOTHES CLOSET IS ONE OF THE ORGANIZATION'S THREE MAIN AREAS OF SERVICE. THE GOAL OF EACH OF OUR PROGRAM AREAS IS TO MEET THE NEEDS OF THOSE LIVING IN POVERTY AND THOSE LIVING WITHOUT HOMES IN OUR COMMUNITY. THE CLOTHES CLOSET FUNCTIONS AS A RESOURCE FOR THOSE WHO REGULARLY ACCESS SERVICES AT SHEPHERD'S TABLE. IN 2017 WE PROVIDED CLOTHING AT NO CHARGE TO AN AVERAGE OF 210 PERSONS PER MONTH AND 2,740 DUPLICATED PERSONS OVER THE COURSE OF THE YEAR.

ALL OF SHEPHERD'S TABLE SERVICES ARE LOCATED IN PROGRESS PLACE, A COUNTY OWNED FACILITY IN DOWNTOWN SILVER SPRING. WE DO NOT PAY RENT OR UTILITIES. TOTAL ESTIMATED VALUE FOR USE OF THE FACILITY IS \$374,490 PER YEAR, A PORTION OF WHICH WOULD BE ALLOCATED TO THIS PROGRAM BUT WHICH IS NOT INCLUDED IN THE EXPENSES SHOWN ABOVE.

IN ADDITION, WE HAVE A STRONG VOLUNTEER BASE WHO SERVE IN A VARIETY OF WAYS. FOR THE CLOTHES CLOSET, AN AVERAGE OF 15 VOLUNTEERS SERVE EACH MONTH, GIVING APPROXIMATELY 60 HOURS OF SERVICE EACH MONTH.

THE MEAL PROGRAM IS ONE OF THE ORGANIZATION'S THREE MAIN AREAS OF SERVICE AND IS CORE TO OUR MISSION. THE MEAL PROGRAM IS DIVIDED INTO AREAS OF SERVICE - BREAKFAST, LUNCH AND DINNER ON WEEKDAYS AND BRUNCH AND DINNER ON WEEKENDS. WE HAVE NEVER MISSED A DAY OF SERVICE IN OUR 35 YEARS. IN 2017 WE SERVED 24,791 BREAKFAST MEALS, 27,547 LUNCH MEALS, 53,781 DINNER MEALS AND 11,830 BRUNCH MEALS FOR A TOTAL OF 117,949 MEALS TO AN AVERAGE OF 120 PEOPLE.

ALL OF SHEPHERD'S TABLE SERVICES ARE LOCATED IN PROGRESS PLACE, A COUNTY OWNED FACILITY IN DOWNTOWN SILVER SPRING. WE DO NOT PAY RENT OR UTILITIES. TOTAL ESTIMATED VALUE FOR USE OF THE FACILITY IS \$374,490 PER YEAR, A PORTION OF WHICH WOULD BE ALLOCATED TO THIS PROGRAM BUT WHICH IS NOT INCLUDED IN THE EXPENSES SHOWN ABOVE.

IN ADDITION WE HAVE A STRONG VOLUNTEER BASE WHO SERVE IN A VARIETY OF WAYS. FOR OUR MEAL PROGRAMS WE HAVE AN AVERAGE OF 924 VOLUNTEERS SERVING EACH MONTH PROVIDING OVER 2,295 HOURS OF SERVICE EACH MONTH.

THE RESOURCE CENTER IS ONE OF THE ORGANIZATION'S THREE MAIN AREAS OF SERVICE AND IS CORE TO OUR MISSION. THE RESOURCE CENTER PROVIDES SOCIAL SERVICES INCLUDING INFORMATION AND REFERRAL, CRISIS INTERVENTION, TRANSPORTATION ASSISTANCE, PRESCRIPTION ASSISTANCE, MAIL SERVICE, TELEPHONE USE, TOILETRIES, AND OTHER BASIC NEEDS. THE RESOURCE CENTER ALSO COORDINATES THE SERVICES OF OUR EYE CLINIC. OUR GOAL IS TO MEET THE NEEDS OF THE PEOPLE WHO COME TO OUR RESOURCE CENTER EITHER THROUGH DIRECT SERVICE OR REFERRAL TO OTHER PROVIDERS.

STATISTICS FOR 2017 INCLUDE: RESOURCE CENTER - 1,788 UNDUPLICATED CLIENTS, 15,703 CONTACTS FOR SERVICES, 863 NEW CLIENTS. PRESCRIPTIONS FILLED - 648 FOR 232 CLIENTS. EYE CLINIC - 266 PATIENTS WITH 260 PRESCRIPTION GLASSES DISPENSED. AT THE RESOURCE CENTER, 22 VOLUNTEERS SERVE ON A MONTHLY BASIS PROVIDING OVER 143 HOURS OF SERVICE EACH MONTH. 2 EYE CLINIC VOLUNTEERS PROVIDED 15 HOURS OF SERVICE EACH MONTH.
