THE GOAL OF EACH OF OUR PROGRAM AREAS IS TO MEET THE NEEDS OF THOSE LIVING IN POVERTY AND THOSE LIVING WITHOUT HOMES IN OUR COMMUNITY. THE CLOTHES CLOSET FUNCTIONS AS A RESOURCE FOR THOSE WHO REGULARLY ACCESS SERVICES AT SHEPHERD'S TABLE. IN 2018, WE PROVIDED CLOTHING AT NO CHARGE TO AN AVERAGE OF 217 PERSONS PER MONTH AND 2,607 DUPLICATED PERSONS OVER THE COURSE OF THE YEAR.

ALL OF SHEPHERD'S TABLE SERVICES ARE LOCATED IN PROGRESS PLACE, A COUNTY OWNED FACILITY IN DOWNTOWN SILVER SPRING. WE DO NOT PAY RENT OR UTILITIES. TOTAL ESTIMATED VALUE FOR THE USE OF THE FACILITY IS \$385,724 PER YEAR. A PORTION OF WHICH WOULD BE ALLOTTED TO THIS PROGRAM
