IT IS OPEN ONE DAY EVERY WEEK TO PROVIDE CLEAN, GENTLY USED AND SEASONALLY APPROPRIATE CLOTHING THAT IS DONATED TO SHEPHERD'S TABLE FOR DISTRIBUTION TO ALL MEAL GUESTS/CLIENTS IN NEED OF SUCH RESOURCES. WHILE IN THE CLOTHES CLOSET PEOPLE ARE GIVEN TIME TO SELECT CLOTHES, SHOES, HANDBAGS, ETC. WITH THE ASSISTANCE OF A VOLUNTEER AND THEY ARE OFFRED NEW UNDERWEAR AND SOCKETS WHEN SUCH ITEMS ARE AVAILABLE. IN 2019, WE HAD 131 VOLUNTEER SHIFTS IN THE CLOTHES CLOSET PROVIDING 387 HOURS OF VOLUNTEER SERVICE.

WE PROVIDE BREAKFAST, LUNCH AND DINNER ON THE WEEKDAYS AND BRUNCH AND DINNER ON THE WEEKENDS 365 DAYS PER YEAR. IN 2019, WE SERVED 26,845 BREAKFAST MEALS, 29,914 LUNCH MEALS, 54,155 DINNER MEALS AND 11,899 BRUNCH MEALS FOR A TOTAL OF 122,813 MEALS TO AN AVERAGE OF 370 PEOPLE PER DAY. IN 36 YEARS WE HAVE NEVER MISSED A MEAL.

ALL OF SHEPHERD'S TABLE SERVICES ARE LOCATED IN PROGRESS PLACE, A COUNTY OWNED FACILITY IN DOWNTOWN SILVER SPRING. WE DO NOT PAY RENT OR UTILITIES. TOTAL ESTIMATED VALUE FOR THE USE OF THE FACILITY IS \$397,296 PER YEAR. A PORTION OF WHICH WOULD BE ALLOTTED TO THIS PROGRAM. IN ADDITION, WE HAVE A STRONG VOLUNTEER BASE WHO PREPARE,
